#### **GDPR Privacy Policy**

# **Protecting your privacy**

This Privacy Policy explains how GMMCO Limited (hereinafter referred to as "Company" or "We" or "Us") collect, use, share, and protect information in connection with the Company services that refer or link to this Privacy Policy ("our Services"). This Privacy Policy applies regardless of the type of device you use to access our Services. This Privacy Policy defines what type of Personal Information the Company collects when you access the Company website or at the time of any other business transaction with our Company, how we use and share that information and what choices are available to you regarding the use of your personal information. We advise you to read this Privacy Policy carefully in order to understand the scope of our Privacy Policy. This Privacy Policy applies to GMMCO website and all its subdomains.

For the purpose of the General Data Protection Regulation ("GDPR"), our Company is the 'Data Controller'. This Privacy Policy further specifies the rights available to European Union ("EU") and European Economic Area ("EEA") in compliance with GDPR.



The Company reserves the right to change this Privacy Policy at any time by posting the updated Policy here along with the date on which the Policy was changed. If we make material changes to this Privacy Policy that affect the way we collect, use and/or share your personal information, we will notify you by including a "NEWLY UPDATED" label with the "PRIVACY POLICY" link for 30 days after material changes are made.

#### 1. Information we collect and how we collect it

We collect and maintain personal information about you from many sources to understand and meet your needs, vendor appointments, manage our business, and for other purposes disclosed to you. For example, we collect personal information about you from:

- You, when you voluntarily provide us with information
- Through the vendor registration form of our Company before initiation of any business transactions with our Company
- Cookies

Our Company does not collect personal information about users of GMMCO website, unless you voluntarily choose to provide us with it for any purpose, except in the manner as set out in this Privacy Policy y. If the information is to be collected directly from you, you may in some cases have the option to decline providing that information. However, your choice to not provide information may impact your use of certain features or services. We collect your personal data only after obtaining consent from you and you have the right to withdraw your consent by sending a request to the Privacy Officer from your email ID which is registered with our Company. The Chief Privacy Officer processes such request subject to authentication of your identity and other legal & statutory requirements.

The personal information we collect about you through these various sources is limited to,

- Name, addresses, email and telephone numbers
- Organization name along with designation with whom you are working
- Information provided via survey, focus group or other marketing research efforts

The collection of your personal information is mandatory to enable our Company to either fulfill the request initiated by you on our Company website or for facilitation of any business transaction with you, being a vendor of our Company. If you do not provide this information, we will not be able to provide you either address your request on our Company website and in case of vendors, will be a hindrance in the business transaction contemplated with our Company.

The data collected is only limited to such data which we deem necessary to the elements which are necessary for a shared relationship with GMMCO. They are in no way intrusive or monetized but are merely for business related purposes.

Anonymous information: We may also collect non-personal data, such as referral sites, automatically in order to identify and understand the users' browsing habits. We use such anonymous information to study user's demographics, browsing preferences and interests. Such anonymous information is outside the scope of this Privacy Policy.



#### **Minors**

The Company does not knowingly collect personal information directly from children—persons under the age of Eighteen (18), or another age if required by applicable law, other than when required to comply with the law or for safety and security reasons.

#### Automatically collected information (including cookies and geolocation)

When you use our Services, we may receive technical information such as your browser type, the type of operating system you use, your geolocation, the name of your internet service provider, mobile advertising identifiers, and pages visited on our Services. Our Company gets this information by using technologies, including cookies, web beacons, and mobile device geolocation to provide and improve our Services and advertising, including across browsers and devices (also known as cross-device linking). We also use this information to verify that visitors meet the criteria required to process their requests and for reporting activity on our Services. What are the different types of cookies that our Company uses?

# There are four types of cookies used on our Services:

- Essential cookies These cookies enable you to use our Services. These cookies are
  essential to enable you to browse our Services and use certain features. Disabling them may
  prevent you from using certain parts of the Services. Without these cookies, services like
  shopping activity and paying activity cannot be provided. These cookies also help keep our
  Services safe and secure.
- 2. Preference cookies These cookies store information such as your preferred country and language selection, account login data and website preferences. Without these cookies, our Services may not be able to remember certain choices you've previously made or personalize your browsing experience by providing you with relevant information. The Company uses reasonable technical, administrative, and physical measures to protect your personal information. When your personal information is shared, the Company takes a reasonable approach to prevent the unauthorized use of personal information.

Please note, however, that while the Company attempts to safeguard your personal information, no method of transmitting or storing electronic information is ever completely secure, and thus we make no warranty, express, implied, or otherwise, that your information will never be accessed, used or released in a manner that is inconsistent with this Privacy Policy.

IN NO EVENT SHALL OUR COMPANY BE LIABLE FOR ANY DAMAGES (WHETHER CONSEQUENTIAL, DIRECT, INCIDENTAL, INDIRECT, PUNITIVE, SPECIAL OR OTHERWISE) ARISING OUT OF, OR IN ANY WAY CONNECTED WITH, A THIRD PARTY'S UNAUTHORIZED ACCESS TO YOUR INFORMATION, REGARDLESS OF WHETHER SUCH DAMAGES ARE BASED ON CONTRACT, STRICT LIABILITY, TORT OR OTHER THEORIES OF LIABILITY, AND ALSO REGARDLESS OF WHETHER WE ARE GIVEN ACTUAL OR CONSTRUCTIVE NOTICE THAT DAMAGES WERE POSSIBLE, EXCEPT AS PROVIDED UNDER APPLICABLELAWS.

Cross Border Transfer:

There shall be no cross-border transfer or data retention for cross border service.

## 3. With whom your information will be shared

#### General

The Company does not share personal information with third parties except as stated in this Privacy Policy.

Where we are required by applicable law, we will seek your consent prior to sharing your personal information with any third party. Also, as described below, you can opt out of



having your information shared with third parties by emailing us at GDPRsupport@gmmcoindia.com.

In the event we undergo a business transition involving another company, such as a merger, corporate reorganization, acquisition, the lease or sale of all or a portion of our assets, or in the event of bankruptcy, information that we have collected from or about you or your devices may be disclosed to such other entity as part of the due diligence or business integration process and will be transferred to such entity as one of the transferred assets.

#### Legal requirements

Further, to the extent required by law, we may disclose personal information to government authorities, or to third parties pursuant to a subpoena or other legal process, and we may also use or disclose your information as permitted by law to protect the rights or property of our Company, our customers, our services, or its users.

# Obtaining and handling your consent

# **Complaint Mechanism**

We shall hold an enquiry upon receipt and accordingly reach out within forty eight (48) hours of receipt on further action to be taken. All costs towards the complaint shall be borne solely by the complainant and GMMCO shall only conduct enquiry upon the same.

## 4. How long does our Company hold of your personal information

Our Company will retain your personal information for as long as it is necessary to fulfil the purpose for which it was collected, and for satisfying any legal, business, accounting or reporting requirements or as required by relevant laws. To determine the appropriate retention period for personal data, our Company considers the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which we process your personal data and whether we can



achieve those purposes through other means, and the applicable legal requirements. For EU residents, our Company endeavours' to delete data within thirty (30) days of a request for erasure or contact you if it will take longer. For more information, please refer Section 6 "Retention" of this Policy.

## 5. Your Rights if you are a EU/ EEA resident

These rights include:

- (a) right of access
- (b) right of data portability
- (c) right of correction
- (d) right of erasure
- (e) right to restrict processing
- (f) right to object

Please note that our Company will require you to provide us with proof of identity, subject to the complete satisfaction, before responding to any requests to exercise your rights and the requests will be entertained only when received from your email ID which is registered/saved in the records of our Company. Our Company shall respond to your request without undue delay and at least within one month (although this may be extended by a further two months in certain circumstances). ## (a) Access

You have the right to know whether our Company processes your Personal Data, and if we do, to access your Personal Data hold and certain information about how our Company uses it and who does our Company share it with.

If you require more than one copy of your Personal Data our Company holds about you, our Company may charge an administration fee.

Our Company may not provide you with certain Personal Data of yours, if providing it would interfere with another's rights or where another exemption applies.

# (b) Portability

You have the right to receive a subset of the Personal Data our Company collects from you in a structured, commonly used and machine-readable format and a right to request that our Company transfers such Personal Data to another party.

The relevant subset of your Personal Data is data that you provide our Company with your consent or for the purposes of performing our Company's contract with you.

#### (c) Correction

You have the right to ask for correction of any Personal Data held about you that is inaccurate. Our Company reserves the right to charge a reasonable administrative fee for this service.

## (d) Erasure

You may request that our Company erases your Personal Data in the following circumstances:

- (i) you believe that it is no longer necessary for our Company to hold your Personal Data;
- (ii) Our Company is processing your Personal Data on the basis of your consent and you wish to withdraw your consent with reasons for such withdrawal and there is no other ground under which our Company can otherwise process your Personal Data:
- (iii) Our Company is processing your Personal Data on the basis of our Company's legitimate interest and you object to such processing. Please provide us with detail as to your reasoning so that our Company can assess whether there is an overriding interest for our Company to retain such Personal Data;
- (iv) you believe your Personal Data held by the Company is being unlawfully processed by our Company along with supporting records to show such unlawful processing.

Please provide as much detail as possible on your reasons for the request to assist our Company in determining whether you have a valid basis for erasure. However, our Company may retain your Personal Data if there are valid grounds under law for us to do so, but we will let you know if that is the case.

# (e) Restriction of Processing to Storage Only

You have a right to require our Company to stop processing your Personal Data other than for storage purposes in certain circumstances. Please note, however, that if we stop processing your Personal Data, we may use it again if there are valid grounds under data protection law for us to do so including any legal or statutory requirements, claims or proceedings.

You may request that our Company restrict processing and just store your Personal Data where:

- (i) you believe Personal Data is not accurate, for the period it takes for us to verify whether Personal Data is accurate;
- (ii) you have objected to our Company processing your Personal Data on the basis of our legitimate interest and you wish our Company to restrict processing your



Personal Data whilst our Company determines whether there is an overriding interest in our Company retaining such Personal Data.

# (f) Objection

At any time you have the right to object to the processing of your Personal Data with our Company on the basis of our legitimate interest and you object to such processing.

Please provide with detail as to your reasoning so that our Company can assess whether there is a compelling overriding interest in our Company continuing to process such data or we need to process it in relation to legal claims. Also note that you may exercise your right to request that we restrict processing of your Personal Data whilst our Company makes the assessment on an overriding interest.

In the event that you wish to make a complaint about how our Company processes your Personal Data, please contact our Company's Chief Privacy Officer and our Company will endeavour to deal with your request as soon as possible.

## 6. Retention

Our Company will retain your Personal Data for as long as it is necessary to fulfil the purpose for which it was collected, and for satisfying any legal, business, accounting or reporting requirements or as required by relevant laws. To determine the appropriate retention period for your personal data, our Company may consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which our Company processes your personal data and whether our Company can achieve those purposes through other means, and the applicable legal requirements.

# 7. Accuracy

Our Company needs your assistance to ensure that your Personal Data is current, complete and accurate. As such, please inform our Company of changes to your Personal Data by contacting our Company Chief Privacy Officer and submitting your updated particulars to in writing.

# 8. Security safeguards

Our Company takes the protection of your Personal Data seriously. However, the transmission of information via the internet is not completely secure. Although our Company will do its best to protect your Personal Data, our Company cannot fully guarantee the security of your Personal Data transmitted through any channel, such as the Website; any transmission is at your own risk.
